Dear Members of Press and People of Ireland,

The Irish Peoples Association (IPA) came into being as a direct consequence of the arrival of the “Covid-19” era, in March of 2020, through a series of meetings in Cahir, Co Tipperary with deeply concerned individuals from across Ireland and of many nationalities. This group had become very suspicious of the immediate “lockdown” of our country, (in lock step with most other countries in the world¹) which destroyed thousands of businesses across this nation and had a devastating impact, psychologically, socio-economically and most significantly, in terms of the health and well-being of a great many of the people on this island.

This group met regularly to discuss the irrational and unlawful administrative actions of the Irish government, which rode roughshod over many of the inalienable rights of the people, whilst ignoring Bunreacht na hÉireann, the Constitution of Ireland. A constitution, which was put in place by the people to protect ourselves from government overreach, through enactment of statutes. Our constitutional rights were not openly discussed by government or the mainstream media (MSM) during the two years of lockdowns, nor during the coercive covid vaccine rollout in Ireland and the unlawful introduction of “vaccine passports”, which led to the segregation of and discrimination against, a large percentage of our society, whose rights were wholly circumvented.

The Irish people, along with those of many other countries, were exposed to a non-stop barrage of covid related media propaganda, radio advertising and biased rhetoric from trusted talk show hosts, generating a climate of fear, and hopelessness. The population was subjected to forced isolation through repeated lockdowns (prison terminology) and unlawful use of our national police force, An Garda Síochána, to enforce nonsensical rules which were contrary to existing medical based evidence². The purpose of this authoritarianism, quite clearly, was to groom and coerce the population for vaccine acceptance, and vaccine passports. The great majority of the Irish population believed that by accepting an untested, experimental gene

therapy sold as a vaccine, they would be protecting their families, neighbours and the wider community, in preventing the transmission of a potentially deadly virus, a belief which now has been shown to be entirely false. "Covid-19" was purported, using computer modelling, to have the potential to kill hundreds of thousands of people. This claim from Neil Ferguson of the Imperial College London, a man who had predicted a similar fate with the swine flu, has been proven to be outrageously inaccurate³. The population was sold a lie. In fact, the death rate in Ireland pre the experimental "vaccine", had dropped marginally in 2020 compared to the previous 5-year average⁴.

The government and MSM moved on from pedalling repeated mind-controlling fear (Prof Mattias Desmet identified this period as mass formation psychosis⁵), to promoting untested, experimental gene therapy, masquerading as a vaccine, to a traumatised and vulnerable nation, which was, we believe, a deliberate plan internationally. Divide and conquer techniques were initiated through the passing of vaccine passport legislation, which brought about vilification, segregation and discrimination against a percentage of the population who had legitimate concerns (now robustly validated) about the experimental injections. Families and friendships were ripped apart and a two-tier society was created.

These untested, and potentially lethal injections were only given emergency use authorisation from the FDA in the US until 2023, as they had no time to be effectively tested, a process which would normally take eight to ten years⁶. The temporary authorisation was obtained after the Covid-19 'pandemic' was declared a public health emergency. In fact, the World Health Organisation definition of a pandemic was changed in 2009 from large numbers of people dying to having no requirement for large numbers of deaths. A pandemic never existed, and still does not exist in the true sense of the word⁷. The illusion of a pandemic was compounded by the deceptive PCR test, used to diagnose "Covid-19". Its inventor Kary Mullis stated that it should never be used for testing for infectious disease and that the PCR test result "doesn't tell you that you are sick"⁸. A Pfizer representative recently admitted to the European parliament that their 'vaccine' was never tested to see if it reduced or prevented transmission⁹. The coercion to take the vaccine to prevent transmission was therefore based on another lie. People who believed they were protecting others were risking their own health for no reason.

One experimental vaccine death is one too many for a virus which has never been isolated in a lab, a vaccine still touted to be “safe and effective”, the greatest lie ever sold. In fact, there have been more injuries and deaths reported following the Covid-19 vaccine than in the entire history of all other vaccines combined¹⁰. Death rates have rocketed across the world following the covid vaccine roll out in 2021¹¹ ¹². Despite this worrying data and the fact that this vaccine had not been adequately tested and no long-term data was available, our government, NPHEA (an unelected body), the HSE and the media continued to coerce people who were at very little risk from Covid-19, including children and pregnant women, to take the injection, putting them and their unborn babies at risk of dangerous side effects including long term injury or death.

Global financial powers, including pharmaceutical giants, have infiltrated governments, universities, media conglomerates, nationally and globally over decades. The ultimate aim, to usher in the World Economic Forum (WEF) proposal, the great reset, referred to many times by WEF leader Klaus Schwab¹³. Members of the current Irish Cabinet have frequented WEF meetings in Davos, Switzerland, including Micheál Martin and Leo Varadkar, a member of the WEF program for young global leaders¹⁴. The actions of the sitting Irish government during the Covid era and beyond, have made it glaringly obvious, that they are no longer serving the Irish people but have redirected their allegiance to Globalist leadership. We believe this to be treasonous and unlawful.

As a direct consequence, one of our groups formed a common law court, similar to the grand jury system in the U.S., to deal with organised crime of a very serious nature in that country. We applied it to Ireland and the crimes against our people that have taken place. We convened our own court, discussed the evidence, which is now becoming very apparent to the global population, and came to our own findings, rulings and a conclusion. Three notices were sent to the acting Minister for Health, Stephen Donnelly between 21st December 2021 and 21st January 2022 asking pressing questions in law about lockdowns, vaccine efficacy and safety, mask mandates and vaccine passports and requesting evidence in justification of all the above government actions. This paperwork from our court “the three-letter process”, can be viewed as part of this press release. Our paperwork, sent by registered post, was acknowledged, but no evidence requested, has ever been forthcoming. An un rebutted claim in law stands as truth.

Therefore, we evoke our inherited, original jurisdiction, aligned with Article 1 of the Constitution, shutting down government and demanding a caretaker administration be put in place pending the outcome of a full-

scale criminal investigation that we now empower our police force to begin. The evidence is abundant and the Irish people will not accept a brush off from authorities who are duty bound and have made sworn declarations to protect the nation and the people. Those sworn declarations supersede any obligation to the former corporate government. This nation is under attack and our future is in grave peril. The former Irish government is acting unlawfully and without mandate from the people, the majority of whom, are still unaware of the high crimes and treason committed against them. Fraud negates all contracts, and the severity of the fraud and treason cancels any social contract the people had with voted representatives automatically.

The members of the IPA, acted in trust for you the Irish people, in absence of your full awareness. We, would not, and will not, accept these Covid crimes against the Irish people and all of the other trusting, compliant peoples of the world. We have been betrayed by the very organisations in this country that we have trusted with our individual health and that of our families and friends. Vaccine injuries and deaths accumulate daily, nationally and internationally, all the while the Irish government and the HSE still promote covid vaccines as “safe and effective” when copious evidence shows the opposite to be true¹⁵. Currently in the UK, in direct contrast to the Irish authorities, the NHS are advertising the entitlement of vaccine injured people to compensation of up to £120,000 in the case of serious covid vaccine injuries or death¹⁶.

The Irish People will not rest until true justice for these heinous crimes is forthcoming, within government structures and corporate organisations in our jurisdiction and internationally. If you have been coerced into acting against your better judgment or have been injured as a result of a “Covid-19 vaccine”, we ask you to come forward to give witness testimony.

If you are a medical professional and were, or are, currently administering covid vaccines without obtaining true informed consent, when evidence was and is widely available, of possible injury or death to those receiving the injections¹⁷, you are complicit in serious crimes and liable. You have a duty of care to your patients to inform of possible harm before injecting them with a potentially lethal poison. Stop immediately and do your research. Saying ‘I didn’t know’ or ‘I was just following orders’ in a future criminal court case is not a valid defence. Trial data that Pfizer was forced to release in January 2021 following an order on a freedom of information request in the U.S. showed that many injuries and deaths had already occurred during the limited trial of the Pfizer ‘vaccine’¹⁸. Pfizer were planning to bury this data for 75 years.

Up to this point the Mainstream Media have been complicit in the crimes committed against the people. They have reported only what aligned with the government and global agenda. Truths that were emerging on the

Do not allow objective journalism to be a thing of the past and stop being complicit in crimes against the people of this country.

To those in power, who have treated the majority of the population as imbeciles, with no ability to do our own research. Did you really think we would not discover your true intentions and where your allegiances now lie and the level of control you want to have over all our lives? Now you use 'climate change' to exert more control. Energy prices are allowed to spiral out of control while our main energy suppliers (Electric Ireland is owned mostly by the people), make bumper profits. Then you say we cannot cut and sell our own turf, to "save the environment". Many ordinary people cannot afford to heat their homes while you are flying around the world on private jets burning thousands of litres of fuel, to meet other elite politicians and business leaders, dictating to us exactly how we should live. The same squadron of elites flying 10,000km from the COP27 summit to the G20 meeting, at the expense of the taxpayer was an irony lost on the MSM. Although the great majority of Irish people have sympathy for victims of warfare, filling our country with refugees from Eastern Europe and North Africa while a serious housing crisis already exists, is a recipe for disaster with the potential for creating volatile gang behaviour with the large influx of mostly young men with no employment prospects living in overcrowded conditions.

We will never forget, there will be no amnesty and there will be lawful and legal judgment for all those engaged in crimes against the people since the beginning of this dark period in our nation's history.

We will start afresh, setting up a new participatory democratic system in every community in this country where the solutions come from the people, a bottom-up system of governance instead of a top down. This is the purpose of the IPA. To make Ireland prosperous. No left, no right, just the Irish people, together. We will do so, however those who are responsible for the state of our nation currently and the crimes committed against us all, must be made accountable in law first.
