NOTICE OF DISHONOUR

Dear Stephen,

In relation to our recent notice of liability sent to your office dated 22/12/2021, where you failed/neglected to answer any of our questions in law, again we say the following:

Can you and the corporate government you work for please provide the following requested information by order of the common law court of County Tipperary;

1. Document & verify any evidence you may have in relation to the safety and efficacy of mask wearing (including any risk assessment tests done on any possible harm to school going children, and active regulation of quality standards by the HPRA and other appropriate government bodies to safeguard the health of the children in the care of the Irish Government).
2. Document & verify any evidence you may have in relation to the efficacy and benefits of lockdowns, in relation to the health of the Irish Nation and risk assessments done. When we say health, this also refers to emotional, spiritual, social and financial health, and not just physical.
3. Document & verify any evidence you may have in relation to the safety and efficacy of the Covid-19 vaccine schedule which began its roll out Spring 2021 (including the HPRA's post marketing surveillance and pharmacovigilance of the Covid vaccines such as real-world effectiveness; monitoring of fatalities and serious adverse events; monitoring of all-cause mortality in the Irish population during the vaccine roll-out and follow-up investigations and coroners reports for vaccine associated fatalities). The safety and efficacy of these experimental vaccines is claimed on all broadcast media daily, including TV, Radio, internet and other broadcast mediums including government and HSE communications.
4. Document & verify any evidence you may have in relation to true informed consent having been given to any member of the Irish nation by any agent of the state or contractor employed by the state, where inoculation has been administered in relation to Covid-19 since Spring 2021 to date.

5. Document and verify any evidence you may have in relation to the fair and balanced debate engaged by concerned members of the public and members of parliament through all media platforms, prior to, and during the rollout of said Covid-19 experimental gene therapy vaccines.
6. Document and verify the evidence you may have with proof that vaccine passports do not discriminate and cause serious harm and trespass on the inalienable rights of the people of the Irish nation.
7. Document and verify the independent decision making process, free of any foreign influence, undertaken by the Irish government in relation to the Covid-19 measures and emergency legislation referred to above. Disclose in full any international agreements or communications that have influenced Irish policies or laws or the constitutional rights of the people.

As we stated in the notice of liability, all power that you presume to enact (acting as law, colour of law, not actual law), comes from the people and the common law courts of eire, which are the superior courts on this land. The common law court is a court of record.

You have now failed/neglected to reply to our very pressing and serious questions in law, in relation to the safety and health of Irish children and adults (including potential death). You are now in dishonour. Your failure to reply to the common law court order a second time may be an admission of guilt in the following areas of law; trespass, battery, malfeasance in office, treason against the Irish people, the non-fatal offences against the person act 1997 in relation to harm, the Irish constitution article 15.4.1 and article 15.4.2 (repugnant statutes), article 40.1 (personal rights), article 40.3.1 (personal rights), article 40.3.2 (personal rights), article 40.6.1.i (personal rights) and more.

May we remind you, statute law, constitutional law, applies to agents/employees of the state where you may be guilty in your public office capacity. Again, common law jurisdiction is the highest form of law, where once found guilty by the common law court, a commercial lien will be placed on your private property/properties. Also, the appropriate authorities will be contacted with an abundance of evidence in relation to alleged crimes committed by you and other affiliated actors. The man Stephen Donnelly will be tried for crimes in a common law court.

We say all information in this notice to be true, under penalty of perjury. We give you seven (7) days on receipt of this notice to reply.
